2018 Council elections underway

Based on the staggered election process in the College's by-laws, elections are taking place this year in Districts 2, 4 and 6.

At the close of nominations on January 4, Danielle O'Connor ND, (District 2 - South) and Tara Gignac, ND (District 6 – North Central) were both acclaimed for three-year terms because no other nominations were received in these Districts.

Shelley Burns, ND and Madeleine Elton, ND were both nominated in District 4 (Toronto East) so a vote must take place. On February 6, Members eligible to vote in District 4 were emailed a link to cast their online ballot by no later than March 8, 2018.
