Important changes to Mandatory Self-Reporting

We sent a profession-wide email on June 14 to let Members know about new requirements applicable to all Ontario NDs and what you need to do to comply. To recap, please read the "Reportable Information" questions below.

- If you answer yes to any of them, you must <u>report the information</u> to the College. Failure to do so may result in findings of professional misconduct which may include a variety of penalties against you and your registration to practise.
- If your answers are all no, you do not need to do anything.

Reportable Information

- 1. Are you currently registered with any other regulatory body in Ontario and/or any other Canadian, US or international jurisdiction? In other words, do you practise or are you authorized to practise another regulated profession in addition to naturopathy?
- 2. Are you currently registered with any other naturopathic regulatory body in any jurisdiction outside Ontario?

- 3. Has a finding of professional misconduct or incompetence been made against you by another regulatory body in Ontario and/or in any other jurisdiction?
- 4. Have you been charged with any offence? An offence means any breach of law that is prosecuted in a court including criminal or drug charges, speeding or parking tickets, etc.
- 5. Have there been any findings of guilt, professional negligence, or malpractice against you?
- 6. Are there any bail or release restrictions currently in place?

Note that these reporting requirements apply as of May 1, 2018 to all regulated health professionals in Ontario. This means that should any of these occur during the course of a year, you are legally required to report them to the College as soon as reasonably possible but no longer than 30 days from the date of occurrence. You cannot wait until the annual renewal of your registration to advise the College of these events.

Other Mandatory Reports

In addition to the above, our website includes a list of <u>all Mandatory Reports</u> (e.g., sexual abuse, child abuse, patient privacy breaches, etc.).

I know I can't provide information to my patients about vaccinations since it is outside of the scope of practice, but what can I say about other forms of treatment that I feel strongly about?

As with a Member's advertising, any information provided to patients must be accurate, true and verifiable as well as within the limits of their knowledge, skill and judgment. While a Member may

have a strong view or opinion about a certain aspect of health care or treatment, professional boundaries dictate that their personal views should not be shared with patients. Members are expected to inform patients only on that which is within the naturopathic scope of practice in Ontario and in a professional, accurate and balanced manner.

If you have been thinking of taking the **Ontario Prescribing and Therapeutics Exam** in order to be able to prescribe drugs such as therapeutic doses of vitamins A and D, folic acid and more, now is an ideal time to <u>enroll in the pre-requisite online course</u> to be able to sit the next exam on October 28, 2018.

Our consultation about proposed revisions to our *Standards of Practice* and *Practice Guidelines* closed last week. Thank you to the Members and organizations that have provided feedback to date. We will report on the results later this summer.
