Notice of Registration Fee Change

The College <u>by-laws (Section 18.04)</u> state that Member registration fees are adjusted annually by an amount equivalent to the change in the provincial <u>Consumer Price Index</u>. They also state that Members must be notified about the change in fees that occurs as a result of this automatic increase.

Registration fees for the coming year will be increased by **1.9%**, the inflationary rate published in the Ontario Consumer Price Index.

Accordingly, fees for the registration year beginning April 1, 2020 will be as follow (not including 13% HST):

Annual Registration Fee - General Class - \$1,609 Annual Registration Fee - Inactive Class - \$807 Late Renewal Fee - All Classes - \$285 Reinstatement Fee - All Classes - \$247

To renew their registration, Members must pay the annual registration fee **and** complete the Information Return form **by 5:00 p.m. on March 31, 2020**. All Members for whom the College has a preferred email address will be sent a link in February to complete their renewal online. Members are encouraged to ensure their preferred email address is listed on their account page (accessible through our <u>website</u>).

Updated Requirement: Advertising Self-Assessment Tool

Advertising can be an important way to let people know about your practice and services. At the same time, Ontarians have a right to accurate and honest information about their health care options.

One of the ways the College helps protect the public is by providing naturopaths with tools to help them meet their professional and legal obligations as regulated health professionals. Our Quality Assurance (QA) Committee plays a key role in responding to issues that matter to the public and/or to NDs.

The QA Committee has updated the Self-Assessment component of the QA Program. Instead of completing various self-assessment questionnaires related to the Core Competencies and Standards of Practice of the Profession, Members are now required to complete one online self-assessment questionnaire specifically focused on advertising. This interactive questionnaire will guide Members through questions designed to check and correct their advertising, including content on websites, social media channels, print and broadcast ads, and other platforms.

While the College will not review individual Members' responses, it will confirm that Members have completed the questionnaire as a declaration on the annual registration renewal form (due no later than 5:00 p.m., March 31, 2020).

The questionnaire should take about 30 minutes to complete, depending on how recently the Member reviewed their advertising and how compliant it is with what is legally allowed.
