#### Complaints Summaries now available online

As part of the College's commitment to transparency, we now include summaries of outstanding complaint investigations on our <u>website</u>, anonymously referenced by complaint file number. The goal is to provide the public and profession with more information about complaints and reports that are reviewed by the Inquiries, Complaints and Reports Committee (ICRC). The ICRC derives its power from the <u>Regulated Health Professions Act.</u> 1991 to deal with concerns about naturopaths' conduct, practice and behaviour.

For health care regulators, transparency is at the core of how we work. Being open in our decisions and providing Ontarians with useful information helps to increase public confidence and trust in the profession's ability to self-regulate.

### Time for the Ontario Prescribing & Therapeutics Course?

More than 540 NDs have successfully completed this voluntary exam. In addition to being able to prescribe drugs such as therapeutic doses of vitamins A and D, folic acid, and more, ND's have cited multiple other benefits to passing the exam. These range from increased collaboration with patients' MDs and pharmacists to being able to access a wider scope. We recommend NDs take three – six months to complete the self-study course before sitting the exam. With the next exam scheduled for October 28, 2018, now is an ideal time for interested NDs to enrol in the course.

#### 2018 Renewal a success!

Ontario's naturopaths are clearly engaged in this part of the regulatory process, with 97.6% of Members renewing on time. For many regulatory Colleges, an 80% renewal rate is the norm. Registration renewal is so much more than filling out a form or paying the necessary fees. It represents an ND's commitment to providing the public with safe, competent and ethical care.

Special thanks to Members who answered our renewal satisfaction survey. Members gave the process an overall rating of 4 stars (with 1 being the lowest and 5 the highest). We received positive feedback on improvements to the forms and website over the previous year. In 2019, we look forward to incorporating Members' suggestions about ways to further improve the process. Sixty-seven Members took advantage of the new Payment Plan Program, launched this year as a pilot to allow interested Members to spread their renewal fee payment over several months.

#### Can I send my patient to their Medical Doctor for laboratory tests?

Yes, you may send a patient to their family doctor, or other health care provider who has the authority to order laboratory tests, for this purpose. The lab tests may or may not be on the <u>list of tests</u> that naturopaths may order. However, it is not sufficient to send the patient with a list of laboratory tests to give to their doctor. Sending a patient to another health care provider for a specific purpose is a referral. Certain information, as outlined in the <u>Referrals and Consultations Guideline</u>, should be included and provided directly to the health care provider when requesting a referral.
