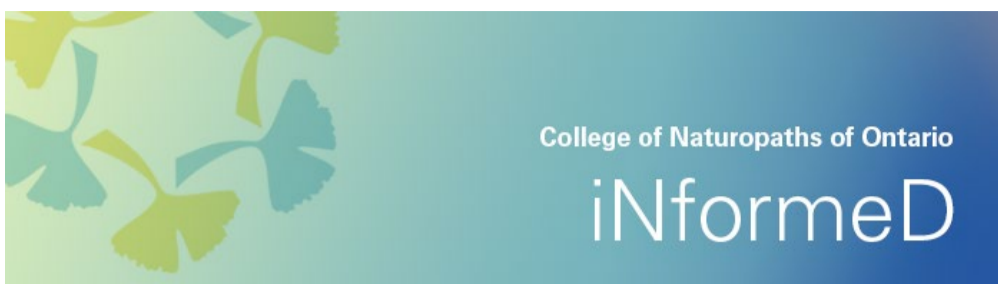

##### **The Annual Registration Renewal for 2023-24 is Now Open!**

To maintain registration with the College, and the ability to practise the profession in Ontario, all Registrants in the General and Inactive classes are required to complete the annual renewal process. [Renewal for the 2023 registration year began at 9:00 a.m. ET on February 14, 2023 and closes at 5:00 p.m. ET on March 31, 2023.](#)

##### **2023 Self-Assessments are Due Next Month**

For the current 2023 renewal year, Registrants are required to complete three online self-assessment questionnaires, including the mandatory Sexual Abuse and Boundaries Self-Assessment, by 5:00 p.m., March 31, 2023.
