



The 2024 Registration Renewal Season is now open!

The annual registration renewal for 2024-25 is now open. Renewing your registration with the College of Naturopaths of Ontario (the College) includes completing the online Information Return form and paying the annual registration fee by **5:00 p.m. ET on Sunday, March 31, 2024.**

**The College will be closed from Friday March 29, 2024, through April 1, 2024. To ensure you meet the March 31, 2024, deadline, you're encouraged to complete your Information Return form early and either pay your renewal fees or enrol in our payment plan. Delays may occur in the processing of submitted Information Returns where College staff need to further review and validate the data provided. Information Forms submitted after 5:00 p.m. ET on March 28, 2024, run the risk of incurring late fees should an Information Return be incomplete or require validation by staff while the College is closed.*

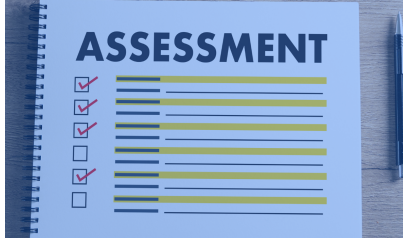


2024 Regulatory Education Program (REP) Topics and Dates Released
