## ***Previewing the 2024 Registration Renewal Season***

The 2024 renewal period begins **February 14, 2024**. Preparing early and submitting your return on time will help ensure an easy and seamless renewal. Here's a list of things you can do in advance to get ready.

*Please note that the deadline for renewal, March 31, 2024, is a Sunday and falls between Good Friday and Easter Monday, Statutory Holidays in Ontario. College staff will not be available after 5:00 pm ET on March 28 until the office re-opens on April 2, 2024. You are therefore highly encouraged to renew early as the data you input on your Information Return form may require review by the College before it can be approved. Leaving the submission of your Information Return form to the end of the renewal period may result in your inability to pay the fees by the deadline which will result in a late fee being added to your account.*

### ***Open Consultation: Data Collection***

The College is considering a program to annually collect additional data from individual Registrants relating to the Standard of Practice for Therapeutic Prescribing, which includes the controlled acts of prescribing, dispensing, compounding, and selling drugs, as well as administering substances by injection and inhalation.
